## PPS Success, LLC Enrollment Agreement

This Membership Enrollment Agreement (the “Agreement”) is made by and between PPS Success, LLC, a California limited liability company (hereinafter “PPSS”) whose principal place of business is Sycamore Business Center, 2111 Industrial Court, Suite A, Vista, CA 92081, and the individual whose name, address and signature appear below (hereinafter “Practitioner”).

### RECITALS

**WHEREAS** PPSS has developed several Membership Programs, including specialized educational courses, consisting of Internet-based slideshows, audios, videos, **teaching materials, textbooks, podcasts, and other digital within** the field of personal, professional, spiritual life mastery, including but not limited to any of the P~P~S Success Mastery Programs (the “PPSS Mastery Programs”); and

**WHEREAS**, the PRACTITIONER identified herein is desirous of enrolling in membership and participating in a PPSS Mastery Program for the purpose of gaining increased knowledge and skill in the mastery of PRACTITIONER’S personal, professional, and spiritual life;

**WHEREAS** PPSS is willing to enroll PRACTITIONER into membership in a PPSS Mastery Program and assist PRACTITIONER in the field of personal, professional, and spiritual life mastery, utilizing PPSS’s proprietary Program Materials in a unique curriculum and participation in a PPSS Mastery Program; and

**NOW THEREFORE**; PPSS hereby agrees to accept PRACTITIONER into one of its PPSS Mastery Program memberships and hereby sets forth the terms under which PRACTITIONER may participate and utilize PPSS Mastery Program Materials received as a member in each PPSS Mastery Program offered.

The P~P~S Success Mastery Unlimited Program will also include access to all practitioner teleconferences and recordings, forums, blogs and the PPSS monthly newsletter, *The Fulcrum*.

Descriptions, assignments, teleconference schedules, and all relevant information will be obtained by the PRACTITIONER via the 'Members Area' portion of the website, [www.ppssuccess.com](http://www.ppssuccess.com) (the “Website”). Membership enrollment in the PPSS Mastery Unlimited Program includes access to all areas of the PPSS Mastery Program described above while the PRACTITIONER membership is in effect..

Descriptions, assignments, teleconference schedules, and all relevant information will be obtained by the PRACTITIONER via the 'Members Area' portion of the website, [www.ppssuccess.com](http://www.ppssuccess.com) (the “Website”). PPSS reserves the right in its sole discretion to continuously revise, change, add to, or subtract from the Program Materials. Access to the practitioner teleconferences and recordings, forums, blogs and the PPSS monthly newsletter, *The Fulcrum* will be limited to 18 months from the PRACTITIONER enrollment date.

**3. PPS SUCCESS MASTERY FIRST STEP PROGRAM**

The P~P~S Success First Step Month Program is a course curriculum and program in the field of personal, professional, and spiritual life mastery specifically designed and created by Paul Chek and others (selected Mentors and Staff) for PPSS. This PPSS Mastery Program will include access to lesson one involving course instruction, including but not limited to internet-based presentations, PPSS lesson materials, downloadable student materials access to online written homework exercises, and supervision utilizing various materials, (hereafter “Program Materials”). The P~P~S Success Mastery First Step Program will also include a copy of Paul Chek's *How to Find and Live Your Legacy* DVD (shipped to you at our expense), access to all practitioner teleconferences and recordings, forums, blogs and the PPSS monthly newsletter, *The Fulcrum*.

Descriptions, assignments, teleconference schedules, and all relevant information will be obtained by the PRACTITIONER via the 'Members Area' portion of the website, [www.ppssuccess.com](http://www.ppssuccess.com) (the “Website”). PPSS reserves the right in its sole discretion to continuously revise, change, add to, or subtract from the Program Materials. Membership in the PPSS Mastery First Step Program will entitle PRACTITIONER to access to the Website and all password-protected PPSS materials available thereon.

Membership enrollment in the PPSS Mastery First Step Program occurs immediately upon successful collection of the enrollment fee from the PRACTITIONER by PPSS. Access to all aspects of Lesson One continues indefinitely until either the PRACTITIONER cancels their membership or PPSS ceases to exist. Access to the practitioner teleconferences and recordings, forums, blogs and the PPSS monthly newsletter, *The Fulcrum* will be limited to 90 days from the PRACTITIONER enrollment date.



**4. PPS SUCCESS MASTERY LIFE SOLUTIONS PROGRAM**

The P~P~S Success Mastery Life Solutions Program is a course curriculum and program in the field of personal, professional, and spiritual life mastery specifically designed and created by Paul Chek and others (selected Mentors and Staff) for PPSS. This PPSS Mastery Program will include any one (1) lesson plan of the PRACTITIONER'S choosing involving course instruction, including but not limited to internet-based presentations, PPSS lesson materials, downloadable student materials access to online written homework exercises, and supervision utilizing various materials, (hereafter "Program Materials"). The P~P~S Success Mastery Life Solutions Program will also include 45 day access to all practitioner teleconferences and recordings, forums, blogs and the PPSS monthly newsletter, *The Fulcrum*.

Descriptions, assignments, teleconference schedules, and all relevant information will be obtained by the PRACTITIONER via the 'Members Area' portion of the website, [www.ppssuccess.com](http://www.ppssuccess.com) (the "Website"). PPSS reserves the right in its sole discretion to continuously revise, change, add to, or subtract from the Program Materials. Membership in the PPSS Mastery Life Solutions Program will entitle PRACTITIONER to access to the Website and all password-protected PPSS materials available thereon.

Membership enrollment in the PPSS Mastery Life Solutions Program occurs immediately upon successful collection of the enrollment fee from the PRACTITIONER by PPSS. Access to all aspects the specific lesson purchased continues indefinitely until either the PRACTITIONER cancels their membership or PPSS ceases to exist. Access to the practitioner teleconferences and recordings, forums, blogs and the PPSS monthly newsletter, *The Fulcrum* will be limited to 45 days from the PRACTITIONER enrollment date.

**5. PRACTITIONER FEES AND PAYMENT OPTIONS**

As consideration for the opportunity to participate in the PPSS Mastery Program, PRACTITIONER agrees to pay to PPSS the amount and payment terms set forth below for membership in each PPSS Mastery Program. Amounts of future membership and programs are subject to change at PPSS's sole discretion.

**The current fees for membership enrollment, including participation in the P~P~S Success Mastery Program are as follows:**

*PPS Success Mastery Unlimited Program* - US \$4740.00, payable upon acceptance of PPSS's Participation Agreement.

*PPS Success Mastery 18 Month Program* - US \$2497.00, payable upon acceptance of PPSS's Participation Agreement.

*PPS Success Mastery First Step Program* - US \$497.00, payable upon acceptance of PPSS's Participation Agreement.

*PPS Success Mastery Life Solutions Program* - US \$247.00 per lesson, payable upon acceptance of PPSS's Participation Agreement.

For all PPSS Programs, PRACTITIONER will be responsible for any long distance and internet connection charges incurred to access the PPSS site and participate in the PPSS Mastery Program teleconferences and PPSS makes no representation regarding these charges. In addition, PRACTITIONER will also be responsible for, and agrees that there may be additional charges for



purchase of other suggested PPSS Mastery Program Materials. Any *suggested* educational materials, beyond course-required materials, may be purchased via links on the Website. The purchase of such materials is not mandatory and is at the Practitioner's sole discretion and expense.

### Refund Policy

Membership enrollment fees are non-refundable, provided that each PRACTITIONER has the right, subject to paragraphs 6 and 7 below, for the current Program in which the PRACTITIONER is enrolled, to request a refund of the Membership less 3% (three percent) for material costs and administrations fees. Such a refund must be requested within **six weeks after enrollment** in any PPSS Program. Thereafter, the membership enrollment fee is non-refundable.

### 6. PRACTITIONER COMMITMENT AND OBLIGATIONS:

PRACTITIONER hereby agrees to the following terms and conditions:

- (a) PRACTITIONER agrees that his or her intention for enrolling in Membership and attending the PPSS Mastery Program is for the purpose of achieving mastery in the areas of PRACTITIONER'S personal, professional, and spiritual life.
- (b) PRACTITIONER shall receive password-protected access to the PPSS-exclusive portion of the Website. PRACTITIONER'S password shall be the sole property of the PRACTITIONER, may not be shared with any third party, and is not transferable or assignable. Sharing passwords may result in the PRACTITIONER being dismissed from the Program for "cause" and barred from access to the PPSS portion of the Website, with no refund for enrollment fees. PRACTITIONER must promptly notify PPSS if the PRACTITIONER'S password has been lost, stolen, or accessed by any third party so that the password can be invalidated and a new password assigned. ***Dismissal from Membership for 'cause' shall result in forfeiture of all fees paid, notwithstanding anything contained herein to the contrary.***
- (c) PRACTITIONER shall attempt to complete the homework exercise for every lesson studied and submit their answers to PPSS for review in a timely manner prior to being granted access to another of our 12 lessons. PPSS will review the homework and determine whether to authorize the PRACTITIONER to move on to another lesson plan based on PRACTITIONER'S completed homework. PPSS's objective is to ensure that PRACTITIONER is absorbing, integrating, and executing the PPSS Mastery Program Materials covered in order to maximize achievable results. If PRACTITIONER is so authorized, PPSS will provide PRACTITIONER with access each subsequent lesson plan.
- (d) PRACTITIONER may elect to move through the lessons at a slower rate than the suggested monthly PPSS Mastery Program lesson structure, provided that once the specific PPSS Mastery Program the PRACTITIONER is enrolled in concludes, PRACTITIONER understands that he/she will no longer receive personal supervision of the PRACTITIONER'S homework, and will only have access to website-based lesson materials, not including practitioner teleconferences and recordings, forums, blogs and the PPSS monthly newsletter, *The Fulcrum*. All homework assignments turned in after program expiration will be reviewed and responded to on an *as available basis* by the PPSS Mastery Program instructor(s).
- (e) PRACTITIONER shall have the right to access and download archived, recorded

teleconferences via the Website, while their Membership is in effect, in the event that PRACTITIONER is, for example, either unable to attend the teleconference, needs additional time with the current lesson plan prior to moving on to the proceeding lesson plan, or wishes to review teleconference materials.

- (f) PRACTITIONER shall have accessible to him or her, a list of PPSS-approved mentors with whom PRACTITIONER may elect to work independently, at PRACTITIONER'S sole additional cost and expense. Sessions with PPSS-approved mentors will be scheduled via the Website mentor scheduling service. PPSS will continue to provide mentor scheduling services for the PRACTITIONER for a period of two (2) years following PRACTITIONER'S completion of the PPSS Mastery Program.
- (g) PRACTITIONER understands and agrees that all PPSS Mastery Program Materials are protected by copyright, are the sole and exclusive property of PPSS, and PRACTITIONER may not copy or use the information from the PPSS Mastery Program or any PPSS Mastery Program Materials for any purposes other than directly those related to completing the PPSS Mastery Program, including but not limited to teaching or instructing others in the areas of personal, professional, spiritual life mastery, without prior, expressed written permission from the PPSS staff.

**i. *What is copyright infringement?***

*Copyright infringement is not the failure to give someone proper credit (that's plagiarism). You can plagiarize in the public domain by passing it off as your own work (see Attachment D, V. Plagiarism). Copyright infringement is an unlawful appropriation—or unauthorized reproduction—of material protected by copyright. A copyright infringer is anyone who, without permission, exercises any of the exclusive rights granted to authors under the Copyright Act. “Copying can be inferred if the defendant has an opportunity to view the copyright owner’s manual, and if there is substantial similarity between the two works that cannot be explained by mere coincidence.” Lloyd J. Jassin and Steven C. Schechter, The Copyright Permission and Libel Handbook (New York, NY: John Wiley & Sons, Inc.), 1998.*

### **7. PPSS MASTERY PROGRAM MATERIALS**

The PPSS Mastery Program Materials, including all original textbooks, videos, tests, student materials, tapes, recordings, podcasts, PPSS Manuals, graphs, audiovisual exhibits, overheads and slides, and any other materials of any type in any medium presented as part of the PPSS Mastery Program, are the exclusive intellectual property of PPSS. PPSS Mastery Program Membership does not confer on PRACTITIONER any right to use any trademark, trade name, trade dress, service mark, copyright, logo, symbol, or other intellectual property of PPSS (hereinafter “PPSS Intellectual Property”). All PPSS Intellectual Property shall remain the sole, exclusive property of PPSS. Any incidental use by PRACTITIONER of PPSS intellectual property under this Agreement shall inure solely to the benefit of PPSS. The PPSS Mastery Program and all Programs and Materials developed hereunder, and all copies thereof, are proprietary to PPSS and all right, title, and interest thereto remains with PPSS. PRACTITIONER agrees not to sell, transfer, or publish any portion of the PPSS Mastery Program or PPSS intellectual property and any such action shall be deemed to be a material breach of this Agreement.

Participation in the PPSS Mastery Program is for each PRACTITIONER'S *individual* benefit. Briefly exposing minimal course materials for the purpose of encouraging others to enroll so that they may be

professionally trained is understandable, expected, and appreciated by the PPSS staff. For the purpose of this Agreement, sharing materials from a single lesson plan shall be considered “minimal.” Sharing more than minimal course materials with others so that they may attempt to educate themselves without enrolling in the program, or for any reason not expressly stated above, is a violation of copyright law and the terms of this Agreement and can result in expulsion from the Program and forfeiture of all fees paid. In addition, such unauthorized use by a third party is highly unlikely to produce the results intended by the PPSS Mastery Program Mentors and PPSS.

***Notwithstanding anything contained herein to the contrary, if PRACTITIONER is found to have used, shared, copied, sold or transferred any PPSS Materials with or to any third party without PPSS’s prior written permission, then PRACTITIONER will be expelled from membership for ‘cause.’ If PRACTITIONER is expelled for cause, PRACTITIONER must return all PPSS Materials and will forfeit PPSS Mastery Program Membership and all fees paid therefore, and PPSS will further exercise all legal rights and remedies and take any legal action necessary to protect the PPSS Mastery Program Materials and other PPSS intellectual property.***

### **8. PPSS COMMITMENT AND OBLIGATIONS:**

PPSS hereby warrants and represents to PRACTITIONER as follows:

- (a) PPSS is the owner of the PPSS Mastery Program and all components thereto.
- (b) PPSS has designed the PPSS Mastery Program to provide training in mastery of personal, professional, and spiritual life concepts.
- (c) PPSS agrees that it shall periodically monitor PRACTITIONER’S homework assignments and provide feedback to assist PRACTITIONER in achieving a high level of competency, integrity, and efficiency in the successful completion of each lesson plan of the Program, as appropriate for that lesson’s concepts and techniques.
- (d) PPSS, upon execution of this Agreement, shall provide PRACTITIONER with access to **one copy of the PPSS Mastery Program Course Manual** and Program Materials for Membership in the PPSS Mastery Program offered under this Agreement. The Program Materials may be retained by the PRACTITIONER upon completion of the PPSS Mastery Program.
- (e) PPSS does not guarantee any specific results for any PRACTITIONER. PRACTITIONER will be given the same training, skills, and opportunity to achieve PRACTITIONER’S potential; however, the application and commitment to the use of the PPSS Mastery Program is the sole responsibility of PRACTITIONER.
- (f) PPSS reserves the right to discontinue Membership and access to the Program for any PRACTITIONER for any reason, by refunding said PRACTITIONER’S membership fee, subject to costs as set forth above, which are non-refundable at the time of enrollment, provided that said membership fees are non-refundable in the event that membership and Program access is terminated for ‘due cause’ as set forth in paragraphs 6(b) and 7 and elsewhere in this Agreement.



## 9. TERMINATION

This Agreement will continue as long as the PRACTITIONER remains in good standing by adhering to all of the terms, conditions, and obligations set forth in this Agreement. PPSS reserves the right to terminate this Agreement in the event PRACTITIONER fails to satisfy or violates any of the terms and conditions of this Agreement or for other 'due cause.' In the event of the termination by PPSS for such failure by PRACTITIONER to satisfy the terms and conditions of this Agreement or for 'due cause,' PRACTITIONER agrees that PPSS shall not be liable for any direct or consequential damages as a result of such termination. Examples that may lead to discontinuation of membership include but are not limited to: **plagiarizing PPSS Mastery Program course materials, sharing individualized pass codes with non-members of the PPSS Mastery Program, attempting to teach PPSS course materials to others not registered in the PPSS Mastery Program.** PRACTITIONERS are welcome and encouraged to show the others how their participation in the PPSSMP has benefited them and others by becoming a living example of the teachings.

## 10. INDEMNITY

PRACTITIONER agrees to hold PPSS, its officers, directors, instructors, owners, agents, information providers, affiliates, licensors, and licensees harmless from and defend against all liability, claims, costs, expenses and demands on account of damage or liability of any kind whatsoever, including reasonable attorneys' fees and costs, incurred by PPSS which arises out of or is in any manner connected with, or is claimed to arise out of or be in any manner connected with the terms of this Agreement and PPSS Mastery Program membership.

## 11. LIMITED LIABILITY

PPSS SHALL NOT BE LIABLE TO PRACTITIONER OR TO ANY THIRD PARTIES FOR ANY INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR EXEMPLARY DAMAGES, WHETHER IN AN ACTION BASED ON CONTRACT, TORT (INCLUDING NEGLIGENCE) OR ANY OTHER LEGAL THEORY, INCLUDING BUT NOT LIMITED TO LOSS OF ANTICIPATED PROFITS OR BENEFITS OF USE, EVEN IF PRACTITIONER HAS BEEN ADVISED OF THE POSSIBILITY THEREOF. IN NO EVENT WILL PPSS'S LIABILITY TO PRACTITIONER, REGARDLESS OF THE FORM OR CLAIM OR ACTION, EXCEED A SUM EQUAL TO THE AMOUNTS PAID FOR THE PPSS MASTERY PROGRAM UNDER THIS AGREEMENT. THIS LIMITATION IS CUMULATIVE FOR ALL AMOUNTS PAID TO PPSS FOR CLAIMS OR DAMAGES BEING AGGREGATED TO DETERMINE SATISFACTION OF THE LIMIT. THE EXISTENCE OF MORE THAN ONE CLAIM WILL NOT ENLARGE THE LIMIT.

## 12. ASSIGNMENT OF AGREEMENT

PRACTITIONER may not assign the rights or delegate the duties created by this Agreement in whole or in part to any person or entity. Any attempt to do so shall result in the immediate termination of the Agreement.

## 13. SEVERABILITY

Should any provision of the Agreement be determined to be invalid or unenforceable, this Agreement shall be modified but only to the extent necessary to bring such invalid or unenforceable provision into compliance and render it valid and enforceable, and such determination shall not affect any or all of the

other terms or provisions of this Agreement which shall continue in full force and effect.

### **14. INDEPENDENT STATUS**

The parties hereto are and shall remain independent contractors in all respects. This Agreement does not constitute and shall not be construed as creating a partnership, joint venture, or an employee-employer relationship.

### **15. NO WAIVER**

The failure by any party to exercise any right provided for herein shall not be deemed a waiver of any other right hereunder.

### **16. NOTICE**

All notices required or permitted to be given by one party to the other under this Agreement shall be sufficient if sent by certified mail or equivalent to the parties at the respective addresses set below, or to such other address as the party to receive the notice has designated.

### **17. CHOICE OF FORUM/GOVERNING LAW**

This Agreement shall be governed by, construed, and enforced in accordance with the laws of the State of California. Any dispute arising under this Agreement may be brought only in a court of competent jurisdiction in San Diego County, California.

### **18. ACCEPTANCE OF AGREEMENT**

By choosing the "I have read your Terms and Use and agree with them" radio button in our online cart during purchase, you are agreeing to the terms set forth in this agreement and accept that it is a binding contract.

### **19. COMPLETE AGREEMENT**

This Agreement sets forth the entire understandings of the parties as to the subject matter and may not be modified except when executed in writing and signed by both parties.



## Attachment A

### Reference Guidelines for P~P~S Success Mastery Program Practitioners

#### I. Permission to Use Material

Written permission **must be** obtained from PPSS before **any** Program Material, including but not limited to **any** course material, manuals, books, videos, articles written by Paul Chek or produced by PPSS, may be used or produced for PRACTITIONER'S individual use, distribution or monetary gain.

#### II. Request for Permission

Attachment F is the “*Request for Permission to Reprint*” form to be used in order to obtain permission to reprint any material from PPSS or Paul Chek. Attachment G is the “*Request for Permission to Use Material in a Presentation*” form to be used in order to obtain permission to use any material from PPSS or Paul Chek in a presentation that PRACTITIONER wishes to give, whether live, broadcast, or recorded on any type of media. Absent written authorization by Paul Chek or PPSS permission is not authorized.

#### I. Right of Publicity

- A. Jonathan Kirsch states, “As a general proposition, the use of a name or likeness of an individual in a work that touches upon a matter of public interest or public concern is unlikely to be a violation of the right of publicity. Thus, for example, it is permissible (and commonplace) to write an “unauthorized” biography of a public figure without violating his right of publicity—but it probably is a violation to falsely claim, whether openly or by implication, that the public figure has endorsed the book” (Ref. 2 p.161).
- B. In simple words, you may not make any implications that Paul Chek has endorsed your work with written “authorization” from PPSS or Paul Chek. Authorization means you have express written permission to use the specific material requested.

#### IV. Documenting Sources

To quote Joseph Gibaldi, “You must document everything that you borrow – not only direct quotations and paraphrases but also information and ideas.” He also states that, “you must indicate the source of any appropriate material that readers might otherwise mistake for your own. If you have any doubt about whether or not you are committing plagiarism, cite your course or sources” (Ref. p.129). (See citation below.)

#### V. Plagiarism

The word plagiarism comes from the Latin word *plagiarius*, which means kidnapper. Joseph Gibaldi suggests that “plagiarism refers to a form of cheating that has been defined as ‘the false assumption of authorship: the wrongful act of taking the product of another person’s mind, and presenting it as one’s own’ (Alexander Lindey, *Plagiarism and Originality* [New York: Harper, 1952] 2). To use another person’s ideas or expressions in your writing without acknowledging the source is to plagiarize” (Ref. 1



p.26).

## VI. Copyright/Author's Idea

- A. When any documentation includes a copyright notice, (© immediately followed by the name of the copyright owner and date of publication), you must properly reference that piece of work. Failure to do so may lead to penalties for act of infringement.
- B. Was the author's idea new, original, and concrete?  
The "Poor Man's Copyright" states that if there is proof that the author was in possession of written materials on a specific date the author may be able to pursue a lawsuit against the guilty party.
